MEMBERSHIP FRAMEWORK

(January 6, 2008)

GENERAL CONDITIONS


1. Individuals wishing to become members of the Bowen Island Golf Association (BIGA) dba the Bowen Island Golf Club (BIGC, "the Club"), agree to abide by the rules of the Club which may be changed by the management and Board of Directors from time to time.
2. Initiation Fee, Annual Dues and any Assessments are payable to the Bowen Island Golf Club.
3. On becoming a member, all members are required to pay the Annual Dues, *except Charter members*, plus any Assessment as levied by the Club from time to time. Non payment of Annual Dues or an Assessment will invalidate the membership privileges of any member.


I. **CHARTER MEMBER**


- 🏌️ **INITIATION FEE** ~ \$20,000 + GST/member.
- 🏌️ **ANNUAL DUES** ~ NIL. A Charter member shall have free playing privileges, *for their lifetime*, provided their membership is in good standing.
- 🏌️ **ASSESSMENTS** ~ Charter member is required to pay any assessment as noted in General Conditions.
- 🏌️ **BOOKING PRIVILEGES** ~ Charter member, and their playing guests, shall have fourteen (14) days advanced booking privileges. Guests to pay regular green fees.
- 🏌️ **VOTING PRIVILEGES** ~ One (1) vote per member.

II. **SPONSORING MEMBER**


- 🏌️ **INITIATION FEE** ~ \$7,500 + GST/member.
- 🏌️ **ANNUAL DUES** ~ Sponsoring member is required to pay Annual Dues in order to maintain their membership in good standing. Payment of Annual Dues will entitle member to play unlimited golf and not pay green fees in that calendar year. Sponsoring member shall be entitled to a ten (10%) percent Annual Dues discount.


 ASSESSMENTS ~ Sponsoring member is required to pay any Assessment as noted in General Conditions.


 BOOKING PRIVILEGES ~ Sponsoring member, and their playing guests, shall have fourteen (14) days advanced booking privileges. Guests to pay regular green fees.


 VOTING PRIVILEGES ~ One (1) vote per member.

III. REGULAR MEMBER

 INITIATION FEE ~ \$1,500 + GST/member.


 ANNUAL DUES ~ Regular member is required to pay Annual Dues in order to maintain their membership is in good standing. Payment of Annual Dues will entitle member to play unlimited golf and not pay green fees in that calendar year.


 ASSESSMENTS ~ Regular member is required to pay any Assessment as noted in General Conditions.


 BOOKING PRIVILEGES ~ Regular member, and their playing guests, shall have ten (10) days advanced booking privileges. Guests to pay regular green fees.

 VOTING PRIVILEGES ~ One (1) vote per member.


IV. JUNIOR MEMBER (7-18 years inclusive)

 INITIATION FEE ~ \$150 + GST/member.

 ANNUAL DUES ~ As established from time to time by the Club management and Board of Directors which are generally fifty (50%) percent, or less, of Regular member Annual Dues. Non Junior member regular green fees is fifty (50%) percent of adult regular green fee.

 ASSESSMENTS ~ Not required of Juniors at this time.

 BOOKING PRIVILEGES ~ One (1) day.

 RESTRICTIONS ~ BIGC reserves the right to reasonably restrict tee times.

NOTE:

 General public can book tee times only seven (7) days in advance.

 Green fees ~ See www.bowengolf.com.

NOTE:

1. A non member is not entitled to pay Annual Dues in order to play unlimited golf in any calendar year.
2. Any member whose membership is invalidated shall still be permitted to use the course upon paying the regular green fee.
